The undersigned, pursuant to the Board of Directors' resolution herby files these Articles of Amendment to the office of the Secretary of State.

Article One

The name of the Corporation is Taiwanese Chambers of Commerce of North America.

Article Two

The Section One of the Article Six of the Articles of Incorporation shall be amended as following:

The Board of Directors of the corporation shall adopt, amend or repeal bylaws, provided, however, that any bylaw may be amended by the vote of the directors at any annual meeting or any special meeting called for that purpose in according to the bylaw provisions regarding amendment as adopted by the Board of Directors.

Article Three

The address of its registered office shall be changed to 8408-B Beechnut St., Houston, TX 77036; the name of its registered agent at such office remained the same.

Article Four

Except for the changes stated above, the original Article of Incorporation which was filed in the office of the Secretary of State on the 13th day of October, 1988, and further registration and statement filed are remained the same.

Article Five

The amendment was adopted at a duly called meeting of the Board of Directors held on the 18th day of June, 2005 and received the vote of majority of the directors in office. The amendment was further adopted at duly called annual meeting of the Members held on the 18th day of June, 2005 and received the vote of majority of the members.

The effective date of adoption of the amendment is the 19th day of June, 2005.
